The undersigned, ("Customer"), applies to Nibley City Corporation ("the City"), for water, garbage, storm water, communication fee and sewer services, ("utility services"). In consideration of the acceptance of this application by the City and the rendering of such service, Customer understands and agrees to the following:

1. Customer will pay for such services in accordance with the rules and regulations as applicable for such service now in effect or as the same shall lawfully be amended or changed from time to time.
2. **Utility bills are due on the 20th of the following month as noted on the bill. A late charge of \$5.00, plus 1.75% of the current month's billing will be assessed for payments received after the due date. Accounts with thirty (30) days outstanding balances are subject to shutoff. The City will notify the Customer, in writing, of the delinquency. If payment is not received by noon on the 5th of the month following notification of the delinquency, utility services will be shut off. Accounts that are shut off are subject to a \$50 reconnection fee, which shall be paid, along with outstanding balances which are 30 + days overdue before service is reinstated.**

3. The City, its agents or employees, may enter the above-described premises at all reasonable times for the purpose of rendering of such service.
4. Customer will notify the City at least **one week** in advance of planning termination of service and agrees to pay for services rendered until such termination date.
5. Customer warrants that they have authority to sign this agreement and to grant permission to enter premises to the City.
6. Customer will make certain that the meters and equipment are readily accessible to the City and that there is nothing which would prevent reasonable access thereto.
7. Customer will pay for any damage to the meters or the equipment beyond normal wear.
8. Water meters are city property and access is permitted **only** by authorized City officials.
9. No other water source may be connected to the City's water system, as per Utah Law. The City reserves the right to connect into or with neighboring cities' approved water systems.
10. The City shall have the right to institute collection proceedings by all means available to it, including suit in a court of proper jurisdiction. Customer further agrees to pay all costs of collection, including collection agency fees, court costs and attorney's fees.
11. All utility notices given to Customer shall be mailed to the address listed on this application or emailed if the Customer request paperless billing.
12. Customer, upon meeting all terms of this agreement, understands that the City has a reasonable amount of time to connect services (within 48 hours or two (2) business days) and agrees that services rendered during any part of a month may be billed based on normal billing period rates.

NOTICE: Utility service fees are the responsibility of all property owners of record under Utah Law regardless of who makes and signs this application.
