## William Masslich—request approval for a building permit to construct an 11' x 48' greenhouse located at 136 W. 3200 S.

Mrs. Penny Trinka was present at the meeting. Commissioner Bliesner noted that this building looked pretty flimsy. Mr. Trinka said it was supposed to be plastic and give four seasons; not three seasons. Commissioner Green stated that he thought a strong wind would take this building down the street. Commissioner Bliesner said the main thing was that they needed to make sure the inside did not catch wind. Commissioner Cook said she did not think there was a problem with the location of the building on the property.

Commissioner Anderson made a motion to approve the building permit application for a 11' x 14' accessory greenhouse at 136 W. 3200 S. as stated in the application. Commissioner Heidt seconded the motion. Commissioner Heidt seconded the motion. The motion passed 5-0; with Commissioner Green, Commissioner Heidt, Commissioner Anderson, Commissioner Cook, and Commissioner Bliesner all in favor.

Commissioner Bliesner said they had found with certain home occupations such as this that they park their equipment in the street and left it there. The street is a public right-of-way and this did pose a safety hazard. They have come to an agreement that this is not appropriate and he anticipated that it would someday be part of the ordinance. He said if the applicant parked in the street while home on lunch it would be fine; they were more concerned with the chronic problems.

(Applicant: Bryan Hickman) Mr. Hickman was not present at the meeting. Commissioner Anderson said the applicant was already an appraiser; and already had a business out of his home for that. Commissioner Heidt said she felt they could approve the conditional use permit and business license without the applicant being present.

Commissioner Anderson made a motion to approve the application for a conditional use permit and business license for Listzero.com/Bryan Hickman located at 355 W. 3575 S. as per the application. Commissioner Heidt seconded the motion. The motion passed 5-0; with Commissioner Anderson, Commissioner Heidt, Commissioner Green, Commissioner Cook, and Commissioner Bliesner all in favor.
