#### OFFICIAL MINUTES OF THE MEETING

##### **Call to Order**

Mayor Shaun Dustin called the Monday, January 4, 2016, Nibley City Council meeting to order at 5:30 p.m. Those in attendance included Mayor Shaun Dustin, Councilman Bryan Hansen, Councilwoman Kathryn Beus, and Council-members Larry Jacobsen, Thomas Bernhardt, and Tim Ramirez. Mr. David Zook, Nibley City Manager, Shari Phippen, Nibley City Planner, and Stephen Nelson, Nibley City Treasurer, were also in attendance. Outgoing Councilman, Ron Hellstern and Outgoing Planning and Zoning Commission Chair, Aaron Bliesner were also in attendance. Councilman Bryan Hansen was not present at the meeting.

##### **Approval of agenda; and approval of the December 12, 2015 meeting minutes**
