> JUDGE STEVENS **ANNOUNCES** RETIREMENT

A lengthy and structured process for naming his replacement will be administered by the State Office of Courts. Mayor Knight will then select from a list of candidates provided by the State and nominate a person to the City Council for their approval.

From the Mayor

We are in the process of preparing the budget for the next fiscal year that starts July 1, 2010. The City Council is required by law to approve a budget by June 20, 2010. The city budget can seem complicated. It is a 23-page document that affects the pocket books of everyone in Nibley City. The overall proposed budget is \$5,114,057. This includes \$1,488,000 from impact fees that are assessed to new homes built in the community. Impact fees offset the costs of providing utility services for this new growth. This budget also includes \$1,857,446 that is collected for our utility funds (i.e., sewer, water, solid waste, storm water). These utility services are funded on a pay-as-you-use basis. For example, you pay a monthly water fee based on the amount of culinary water you use. The utility rates are set by the City Council based on the cost for providing the service.

My main area of discussion is our proposed general fund budget of \$1,768,611. The revenue for the general fund comes from three main sources: property tax, sales tax, and franchise tax. This money pays for library services, law enforcement, and fire protection as well as to build and maintain our parks, trails, and roads. The proposed new budget is 2 percent less than this year's budget of \$1,805,498. We do not expect a decrease in next year's revenue. However, we are budgeting conservatively in case of an unexpected downturn in the economy. Then, at the end of the year, if there is more revenue than expected, we will use that money for one-time projects. Last year, the initial general fund budget revenue was \$1,604,740. By the end of the fiscal year, we expect to receive \$1,805,498. This gives us more than \$200,000 to use on one-time projects. By projecting revenue in this conservative fashion, Nibley City has lessened the affects of bad economic times. During the recent slow economy, we have not had to lay off employees or cut services for a lack of money, as has been the case with many other municipal and state governments throughout the country.

We diligently monitor our budget and frugally spend your local tax dollars. This year's surplus allowed us to fund one-time projects such as:

Additional Park Construction - \$38,000 Community Center Fund - \$15,000

Equipment – Skid Steer - \$36,000 Equipment – Street Sander - \$9,000

We are continuing to improve our park system in Nibley and will add a full time employee in next year's budget to help with parks maintenance. The following are some of the expenses paid for from the general fund:

Community Celebrations - \$22,000 Street Lights - \$27,000

Library User Fees - \$19,000 Pump Culinary Water - \$60,000

Public Safety (Fire & Police) - \$174,000

Park Construction & Maintenance - \$218,500

We will build a 2-million -gallon culinary water reservoir in the coming year using our water impact fees. Many services and functions are performed by Nibley City employees that enhance our quality of life. We operate on a very austere budget which, in turn, has a minimum impact on your taxes. I thank all of those involved in aiding our efforts. If you have questions about the budget, please give me a call.

MOSQUITO CONTROL

Abatement activities (larvacide and surveillance) have begun. Fogging (adult control) will begin when adult mosquito

numbers become high or pools of mosquitoes are found to be positive for West Nile virus. This will likely be around Memorial Day. West Nile virus has already been found in mosquitoes in southern Utah this season. Remember that courtesy no-spray requests must be submitted in writing and must be renewed annually. DISPOSING OF HOUSEHOLD HAZARDOUS WASTES

If you need to dispose of hazardous waste in your home, you can take it to Logan Landfill and inform the attendants of the materials in your possession. Examples of residential hazardous waste include: antifreeze, bleach, tvs, batteries, computers and monitors, gas, cleaners, insecticides/pesticides/fungicides, mercury items, motor oil, paints, and propane cylinders. Disposal is free, with the exception of untagged A/C or refrigeration units or vehicle tires. The Household Hazardous Waste Facility is located at 200 North, 1400 West in Logan. The hours are Monday to Saturday from 8:00 a.m. to 5:00 p.m. For more information, call 435-713-6686.
