Meeting with Malouf and Young Truck and Trailer

We have a new corporate citizen in Nibley. The Young Truck and Trailer Center purchased the Poulsen Trailer facility on US 89-91 earlier this year. The Truck and Trailer Center is part of the Young Automotive Group with locations throughout Utah. When Justin Maughan and I met Randy Taylor from Young Truck and Trailer a few weeks ago, it seemed that Nibley City could play a role in introducing the new neighbor to the Malouf Companies, an established Nibley corporate citizen. We all got together on September 9, and I was inspired by the commitment these two companies have made to less-fortunate members of our society. From their website (https://youngcaringforouryoung.org/), last year The Young Caring for Our Young Foundation fed 18k kids in a weekend, supplied school clothes and coats to 1500 kids, school supplies to 5000 kids, and basic supplies and comfort to more than 600 homeless teens and young moms. You may already know about the Malouf Foundation (https://malouffoundation.org/) and their cause to confront child sexual exploitation. The Malouf Foundation collaborates with healthcare providers, specialists, and law enforcement to prevent exploitation, educate the public, and increase survivor education and healing.

After speaking with the Cache County Clerk/Auditor about those concerns, he asked for a letter listing those concerns. With the goal of remedying the issue in the future, our city attorney provided the requested letter to the Cache County Clerk/Auditor.
